Mayor/Chairman Guidi called the City Council, Community Redevelopment Agency, Parking Authority meeting and Housing Authority to order jointly and concurrently at 6:00 p.m. in the City Council Chambers of the City Hall, 4455 West 126th Street, Hawthorne, California.

Deacon Tom Mosky from St. Joseph's Church gave the evening's invocation.

The Pledge of Allegiance was led by Daily Breeze Newspaper reporter Ian Gregor.

Mayor Guidi requested a moment of silence in honor of the passing of former President Ronald Reagan.

Israel Mora from the Wiseburn Education Foundation and the Wiseburn School District Board of Trustees presented Mayor Guidi and the Council with a plaque and a Certificate of Recognition for their outstanding contribution to the 1st Annual Rock Around the Block.

Under oral comments, **Elizabeth Seour**, 1001 6th St., requested consideration and approval of this condominium project. **Kris Kimble**, addressed the issue of storage. Stated that the garages are 31 feet deep as opposed to a typical garage that is 20 feet deep, thereby giving 11 feet of storage space. **Andy Peranelli**, 4029 W. 133rd St., owner of units west of proposed project, thinks Mr. Kimble's plans are a great idea for that particular street and neighborhood. **Imelda Garcia**, 4084 W. 132nd St., does not want these apartments in back of her house. **Dorothy Shishim**, 4038 W. 133rd St., objects to the condos on 133rd. Feels it will add to parking problems on the street. **Darlene Shuck**, 4045 W. 133rd St., opposes the condominiums because of overcrowding. **Carla Nay**, 4014 W. 132nd St., would consider the project an improvement to the neighborhood. **James Gamble**, 4014 W. 132nd St., believes this project would be a benefit to the community. Allen Richards, 13828 S. Ramona Ave., concerned whether there will be a governing body that regulates the rules and regulations of the property. **Osvaldo Villareal**, 4071 W. 133rd St., spoke in favor of project. **Rosemary Shuck**, 4045 W. 133rd St., suggested a nice parking lot be built in the empty lot instead of the condos in order alleviate the parking problem. **Kris Kimble**, feels he has worked well with the planning department and planning commission and taken all of their input.
