

**MINUTES OF A REGULAR MEETING OF THE  
COMMUNITY REDEVELOPMENT AGENCY OF HAWTHORNE,  
CALIFORNIA HELD MARCH 23, 2004.**

The Community Redevelopment Agency, Parking Authority and City Council meetings were called to order jointly and concurrently by Chairman/Mayor Guidi at 6:00 p.m.

Status of the Exclusive Negotiating Agreement (“ENA”) between the Community Redevelopment Agency and James H. Mitsch, B.T. Imperial LLC, (Jack Fleming, Bentree Real Estate Group) for a proposed mixed-use residential/commercial Project located at 4742-54 Imperial Highway. On January 13, 2004, Mr. Mitsch appeared before the Agency and specifically requested that the Agency continue this item to the March 23, 2004 Agency Agenda.

**RECOMMENDATION:** The Community Redevelopment Agency has not received the revised DDA from the Developer. On March 17, 2004 at 4:00 p.m., the Agency received a facsimile (via “kinko’s”) from Mr. Mitsch requesting an extension “to allow sufficient time to complete the work on the zoning ordinance to define the appropriate development standards to be applied to residential developments for affordable housing” and requesting additional guidance on basic deal points. Agency Staff recommends that this matter be continued to a time that Mr. Mitsch deems necessary to submit the required information.

Agency Member Catano moved, seconded by Chairman Guidi, that this item be continued until the April 27, 2004 City Council meeting.
