

## **BARKING DOG ABATEMENT INSTRUCTION SHEET**

### **Hawthorne Municipal Code section 6.25.010 - Definition**

The Hawthorne Municipal Code section 6.25 (Abatement of Barking Dogs as a Nuisance) states that a dog, which barks in a substantially continuous manner in the daytime or nighttime to the annoyance of people in the neighborhood, is declared to be a nuisance which may be abated by the procedures hereinafter provided.

If you feel that a dog in your neighborhood, by it's barking, falls under this definition, follow the below steps to begin abatement procedures to correct the problem.

1. Contact the Animal Services Bureau at 310-349-2948.
  - a. Have the address of the problem dog.
  - b. When you speak to the Animal Control Officer, they will verify if the dog is licensed in the City of Hawthorne.
  - c. Give the Animal Control Officer your complete name and address.

**Note: your name and address will remain confidential at this point.**

2. The Officer will mail out a "Dog Barking Abatement packet" or, you can download it from the City's website.
  - a. When you receive the packet from Animal Services, complete the **Barking Dog / Incident Report Form** and return to this office.
  - b. Upon receipt of the completed form, we will mail an Abatement Notice to the dog owner advising them that a complaint has been filed with our department and that all noise is to cease immediately.
  - c. You will also receive a letter confirming that we have received your complaint and that the Abatement Notice has been sent to the dog owner.
  - d. After receiving the confirmation letter from Animal Services, keep a log recording the times and dates of the animal disturbances if the problem does not stop.
3. In most cases, this is what is needed to quiet a barking dog. If not, the next step will be to mail a declaration to the dog owner by certified mail.
  - a. In the packet, there will be a Declaration that you may use (or you may write your own) to send to the dog owner.
  - b. After mailing the Declaration to the dog owner, mail a copy to the Animal Services Bureau along with a copy of your log recording the animal disturbances.

Note: At this point, it is necessary that you submit your name and address to the dog owner.

4. Upon receipt of the copy of Declaration, an Animal Control Officer will contact you, will investigate your complaint, and if necessary, hold a City hearing.
