MINUTES OF A REGULAR MEETING OF THE CITY COUNCIL OF THE CITY OF HAWTHORNE, CALIFORNIA HELD SEPTEMBER 23, 2008.

Mayor/Chairman Guidi called the City Council, Community Redevelopment Agency, Parking Authority and Housing Authority meeting to order jointly and concurrently at 6:00 p.m. in the City Council Chambers of City Hall, 4455 West 126th Street, Hawthorne, California.

ROLL CALL-Present: Councilmembers Juarez, Lambert, Parsons, Mayor Guidi.

Absent: Councilmember Catano (excused).

Civil Service Commissioner Darlene Love gave the evening's invocation. Robert O'Brien led the Pledge of Allegiance.

Chairman Alex Monteiro and Treasurer Norm Morton of the Hawthorne President's Council presented a \$5,000 check to Chief Mike Heffner for the K9 program. Monies were raised at a community dinner held in May.

Mayor Guidi recessed the City Council meeting to conduct a **Closed Session**: Conference with Labor Negotiator pursuant to Government Code Section 54957.6. Agency Negotiator: Jag Pathirana - Employee Organization: All Employee Groups.

Mayor Guidi called the City Council meeting back to order following recess with all Councilmembers present except for Councilmember Catano who was excused. He announced that the **closed session** was to discuss a Conference with Labor Negotiator pursuant to Government Code Section 54957.6. Agency Negotiator: Jag Pathirana - Employee Organization: All Employee Groups and announced that the Agency Negotiator was instructed.

Under Elected Officials Reports and Recommendations:

Discussion/Action Items:

• Strategic Plan (Juarez)

Councilmember Juarez requested that this item be on the agenda for the next meeting.

• Moving closed sessions to a different day or to 5pm on regular council meeting days (Parsons)

The council's current policy is to hold closed sessions during the public part of the meeting. Due to Councilmember Parsons hearing a lot of people basically saying they would like it if the closed session could be moved to either later on after public portion or before public portion, Councilmember Parsons would like to see if the will of the Council is to basically not hold a closed session during the public part of the meeting and if there's support for that then the next move would be to determine when we would like to hold the closed session.

Councilmember Parsons moved, seconded by Councilmember Juarez, to no longer hold closed sessions during the public part of the meeting.

Mayor **Guidi** asked Council for a letter of support regarding a foreclosure bill that is being carried by Senator Mark Ridley-Thomas.

Mayor Guidi moved seconded by Councilmember Juarez to go forward with the letter.

NOES: None. ABSTAIN: Councilmember Lambert. ABSENT: Councilmember Catano.

For the record, Councilmember Lambert stated that the only reason she was abstaining is because she does not know what the bill says.

Mayor Guidi announced that Supervisor Burke has park funding money for the city, but that it must be used for multi projects to be spread out through the parks in the city and she would want to see first what projects we would come up with. Continues to be impressed with Hawthorne Blvd. and the two hotels that are 75% finished. Congratulated Planning Director Harold Roth on the CDBG rehab project across from the hotels. Since there was no input from staff for ideas on Imperial, asked to be the point person with staff to design imperial to make it more attractive. Stated that the islands in front of railroad tracks by the pool and the pool look great. Announced that the San Genaro Italian Festival starts Thursday night at Hollywood and Highland. The Jimmy V Bocce Tournament will be held on November 1st at the Hawthorne Memorial Center.

Councilmember **Juarez** stated for the record that if he had the \$500,000 in funds from Supevisor Burke for parks, he would invest it in the pocket park for the folks over in the small section of Hawthorne who have had to put up with debris and all kinds of junk thrown on the dirt lot. Attended the Ramadan event at the Islamic Center and the Cuban Festival. Received the report regarding fireworks sales, but asked for clarification regarding how much money Hope is Helping made. Reported that profit went from \$1300 to \$17, 000. Inquired about passing an ordinance like Carson did which stops the clustering of child offenders. Reported on AB 1778 which would impose fines on people who dig through trash cans. Thanked City Manager Jag Pathirana for the monthly overtime report and asked that when showing the average for 2008-2009 instead of showing an extrapolation, just show an average for the actuals that we have to date. Thanked City Attorney Glen Shishido for the start on the ordinance regarding shopping carts and is still waiting on a report from Licensing Director Lisa Miller regarding the carts before moving forward on this. Also thanked Ms. Miller for the report on film permits in other cities and asked for a report on Hawthorne. Thanked the Planning Commission for granting a CUP to a new restaurant on Imperial Highway, which hopefully will be a gateway to more businesses opening on Imperial. Announced that Goldenstate Water Company is working on replacement meters which should be an improvement on how they collect information and bill us. Inquired on where AT&T will be putting the 4foot metal cabinets for their new U-verse service.

Councilmember **Lambert** thanked Tom Quintana for his help with the earthquake forum and also thanked everyone who attended. Announced that she will be resigning from the South Bay COG due to a conflict with another meeting. Attended the Lions picnic, Cuban Festival and continues to attend the new homeowner association meetings in North Hawthorne.

Councilmember **Parsons** asked for an update on the complaint database of Allied Waste that he asked for. Thanked Councilmember Lambert for organizing the earthquake seminar. Inquired about hiring a consultant regarding earthquake preparedness. Reported the good news that the state finally passed their budget and due to Prop. 1A, the state could not take local money to fix state problems. The bad news is Prop. 1A did not protect money from the Redevelopment Agency and \$650,000 was taken from our redevelopment agency.

Under oral communications **Jose Gutierrez** spoke on Operation Clean Sweep, which was held this past Saturday in the Holly Park area. The event was successful and if other homeowner associations are interested in having an event of this type, they can contact Mr. Gutierrez at josegutierrez@hollyparkhomes.org. Spoke in favor of Measure V, which will update the language of the communication and utility tax. **Kyle Orleman** announced that the VFW Post 2075 and the Ladies Auxiliary are selling the 2009 edition entertainment books. Money raised from the sale of the books will go towards replenishing capital funds that were used to replace the air conditioner at the VFW. The books can be ordered by going to the VFW website at www.vFW2075.org. Donations are also welcome. **Darlene Love**, 2003 W. 116th St., thanked the City Manager and the City for fixing the pits at Holly Park. Also asked about getting handicapped access to the park.
