

**MINUTES OF A REGULAR AND SPECIAL MEETINGS OF THE  
CITY COUNCIL OF THE CITY OF HAWTHORNE,  
CALIFORNIA HELD MARCH 8, 2011.**

Mayor Guidi called the City Council, Community Redevelopment Agency, Parking Authority, Public Finance Authority and Housing Authority meetings to order jointly and concurrently at 6:04 p.m. in the City Council Chambers of City Hall, 4455 W. 126<sup>th</sup> Street, Hawthorne, California.

Pastor David Manila from Oceangate Southern Baptist Church gave the evening's invocation. Frances Stiglich led the Pledge of Allegiance.

**Presentation:** Hawthorne School District Update by Superintendent Helen Morgan (City Council)

Hawthorne Math and Science Academy student board member Andrea Carmona spoke on how HMSA recently became one of 42 high schools in the country to receive a 2010 National Blue Ribbon award. This is a national recognition that established HMSA as one of America's most successful schools. HSMA is the first school in the Hawthorne School District and the first school in the City of Hawthorne to earn this esteemed title. In California, only three other high schools received this award.

**The following presentation was pulled by the Chief of Police until the next meeting.**

Councilmember English presented a Proclamation to Sylvester Quiroz of Los Angeles Universal Preschool in support of preschools.

**Presentation:** City of Hawthorne – Emergency Plan by Claudio Taniguchi (Vargas)

Claudio Taniguchi spoke on the position of the city and what we're doing as a city and as a community to be prepared.

**Certificate of Appreciation:** Hawthorne Imperial Lions Club Student Speaker Winner Presented to Hawthorne Math & Science Academy Student Tiffany Paiva (Juarez)

Councilmember Juarez presented a Certificate of Recognition to HMSA student Tiffany Paiva for her outstanding performance as the first place finisher in the Hawthorne Lions Club Speech Contest and as a finalist in the Lions Zone level competition held March 3, 2011. This was a very remarkable achievement considering that she had never competed in a speech contest before.

The next presentation was an item placed on the special meeting agenda

**Proclamation:** Appreciation to Tom Quintana and Rosalinda Martinez for all of their help on the South Bay Cog Event.

Councilmember **Lambert** presented Certificates of Recognition to Tom Quintana and Rosalinda Martinez for their hard work and dedication in representing Hawthorne at the South Bay Cities Council of Governments 12th Annual General Assembly held on February 25, 2011.

Under oral communications **Alex Monteiro** stated that Hawthorne School District has two other LAUP sites at two schools, one at Zela Davis and one at Eucalyptus and that we should give LAUP our support. **Allen Richards** questioned whether the city is monetarily supporting LAUP. **Barry Levy** questioned what would be the criteria for the success of the program, what are the costs that they said are investments, what are the results since 2005 of the children that have been in the program and are we

aware of the recent study that showed that there is no difference between children who attend head-start programs and those that don't. **Pat Donaldson**, Chamber of Commerce, thanked everybody for attending and for their participation at the State of the City. Announced that the Chamber will hold their next mixer on March 17<sup>th</sup> at Ashley Furniture from 5:30pm to 7:30pm. Regarding the topic of emergency preparedness, mentioned that the Red Cross sells water that is good for five years. Let everyone know that Abacus Security Services has added canines and bomb dogs to their security. **Allen Richards** does not feel that the four vote amendment regarding the city manager position on tonight's agenda is right. Spoke on the benefits that CDBG funds have on the community. Asked for a resolution to tell our representatives to reduce benefits and stop shipping our tax dollars to countries that hate us. **Claudia Hernandez** representing parents at Eucalyptus School, asked for the closing of part of Eucalyptus Avenue for the safety of the students. **Laura Walters**, Community Services Liaison with L.A. County Fire, announced that Daryl Osby is the new fire chief. Reminded everyone that since there will be a time change this weekend, now is also the time to change the batteries in your smoke and carbon monoxide detectors. Asked that parents teach their children what to do in case of fire. **Alex Monteiro** stated that Superintendent Dr. Helen Morgan has contacted the city manager to set up an appointment regarding the issue of closing streets on Eucalyptus and York. Clarified that LAUP provides money for four year olds to go to preschool for free and that the city does not provide any funds. Announced that the next Relay for Life planning committee meeting will be held on March 14<sup>th</sup> at 6 pm at the Hawthorne Moose Lodge. On March 19<sup>th</sup> at 10am everyone will meet at the Hawthorne Pool for the Paint the Town Purple event. Donations are still being collected and are appreciated. Illuminaria bags are also being sold. The Hawthorne Presidents Council Volunteer Appreciation Day will be held on April 17<sup>th</sup> at the Memorial Center at 2pm; applications are due March 21<sup>st</sup>. Tickets are now being sold for the 31<sup>st</sup> Annual Barbeque Dinner for the K9 unit. **Francis Stiglich** presented a Certificate of Recognition for Excellence to Mayor Guidi. Complained that her neighbors are leaving their trash can eight feet away from her dining room window instead of keeping it in their backyard and that there is a house on 120<sup>th</sup> between Ramona and Truro with a lot of garbage in their front yard and why doesn't code enforcement cite them. **Mike Castillo** from Assemblyman Bradford's office invited everyone to attend a healthcare reform committee forum. This event is meant to help explain what the reforms mean at every level of government. It will take place on March 26<sup>th</sup> at the Lawndale library from 12pm to 2pm. Touching on the budget, stated that the assembly conference committee has been going over the different proposals that the governor has submitted and are getting close to a conclusion as far as what they are ironing out on the assembly side. **Kyle Orleman** announced that the Vietnam Veterans of America South Bay Chapter 53 are holding their 16<sup>th</sup> Annual Scholarship Contest. It is open to any high school senior in a South Bay high school. The student must write a 500 word essay pertaining to a family member or a person in their life who has influenced them strongly who is either a Vietnam in-country veteran or a Vietnam era veteran. Four scholarships in the amount of \$1,000 each will be given. The deadline is April 10<sup>th</sup>. For more information, go to [www.vva53.org](http://www.vva53.org). **Juan Carvajal** asked for Council's help and direction in getting current water reports. **Ashery Darnell** expressed concerns on cutbacks from the Hawthorne Youth Basketball League and inquired on how the fees that they pay are being distributed. **Barry Levy** inquired if the city has guidelines on how to dispose of the new mercury light bulbs.

Councilmember Vargas tabled item A

a. – Coordination of spay and neuter clinic at City Hall between Hawthorne Animal Control Department and the Amanda Foundation. Also, publicize event on Channel 22. (Vargas)

b.- Cost and viability of Christmas parade. Result of meeting between city staff members to discuss logistics of parade. (Vargas)

Due to the city running on a skeleton crew, labor laws and city costs, it would not be feasible to have a parade this year. It was suggested that between this year and next, staff look for other means of funding the parade.

c.-Bodger Park Visitor Parking – viability of instituting temporary one or two-day parking permits for visitors on a limited basis. (Vargas)

Councilmember Vargas requested that this item be sent to staff with a focus on two-day temporary visitor parking.

d.- English (LAUP) Resolution / Community Partner (English)

“Item d was part of Councilmember English’s presentation”.

e.- Create a public awareness campaign about recycling styrofoam. Direct staff to meet with Allied Waste to update printed material/literature to include styrofoam as a viable recyclable material. Juarez)

Councilmember Juarez gave direction to update literature to include styrofoam as a recyclable item.

f.- Consider a resolution requiring elected officials and appointed commissioners who attend conferences/seminars/committee meetings on taxpayers funds (general funds) prepare a written report for general distribution through the city managers office. (Juarez)

Councilmember Juarez moved seconded by Councilmember English to create this resolution.

In order to run more efficient meetings and raise the bar on how we conduct business, Councilmember Vargas recommended that the following resolutions:

Certificates, acknowledgements and any other items requiring five signatures will be signed instead of stamped. Before going on the agenda, they will be circulated among council for approval. They will be presented by council as a whole thereby giving each councilmember an opportunity to address the recipient.

A list of groups or organizations that the Councilmembers want to support or partner with. It would require the councilmember moving to add an organization to explain the benefits to the city and whether the group will seek financial support from the city

Directive be limited to two or three and each councilmember that is issuing a directive give justification as to the purpose of the request and how it benefits the city directly.

Under Elected Officials Reports and Recommendations:

Councilmember **Juarez** congratulated Olivia Valentine and Katrina Manning for receiving the 2011 Women of Distinction award. Attended Memorabilia Day which this year was done in memory of Walt Dixon. Congratulated Environmental Charter High School on the grand opening of their new science center. Reminded everyone that on March 31<sup>st</sup> there will be another public hearing on the Crenshaw/LAX Transit Corridor expansion of the maintenance yard at Inglewood City Hall. The next meeting of the Hawthorne Historical Society will be held this Thursday at the Hawthorne Library. The election of officers will also be held at this meeting; anyone interested is encouraged to attend. Anyone interested in participating in the 22<sup>nd</sup> Annual Hawthorne Parks and Recreation Foundation Golf Tournament should contact Dick Huhn or Mark Hardison at the Memorial Center.

Mayor **Guidi** spoke on how companies are closing down in the U.S., sending jobs and manufacturing to other countries because it is cheaper and suggested that an import labor tax be charged to those who want to manufacture out of the country. Challenged the public to bring one American made product to the next council meeting. Thinks all monies for building schools, hospitals and buildings should be made with all American material or we don't fund them. Would rather see the city start its own internal organization, use our housing and our own funds to help the homeless even if we have to build a shelter ourselves. Spoke on the situation with illegal vendors and the trash at the shopping center at 118<sup>th</sup> and Hawthorne and how this is not the vision he has for Hawthorne. Wants to focus on what will bring jobs to the city. Received compliments from SpaceX for the trees on Jack Northrop. Did a walk-through at the 9 to 5 building which will bring a lot of jobs. Thanked Chief Fager for clearing up the prostitution on Imperial which was hurting the local business owners. Is waiting to meet with the fire chief to find out why Hawthorne did not get its fire truck. Inquired why the trash is still being picked up so late in the day. It should be picked up before noon so the street sweeper can go by. Even though it will be difficult, asked if everyone could start buying American and pay a couple of extra pennies in order to create more jobs that would create more stability and income.

Councilmember **Lambert** noticed that a lot of people put their trash on the street rather than on their lawn so that parking is cluttering up and that's why we can't get by those big trucks and maybe that's something that we can correct in the neighborhood. Is worried that Walmart has declared that they want to build a store in an industrial area in El Segundo that is adjacent to the Hawthorne Hollyglen neighborhood on Aviation which would create traffic congestion in the area.

Councilmember **English** reported that the upcoming Service Provider Fair and Earth Day event is quickly filling up and thanked those who have called to sponsor or participate, including South Bay WIB and Wells Fargo. Announced that March is Woman's Month and April is Sexual Harassment Awareness Month. Historically March was the month that women had the opportunity to vote for the first time. Asked that March be recognized in the city as Woman's Month. Thanked Gregg McClain from the Planning department for providing an updated list on the current CDBG and HOME funding applicants; there are still a lot of applicants that are eagerly looking to apply. Attended memorial services on Saturday for Finance Manager Lani Emmich's mother. Thought it was very special to see various department employees from the city attend the service as it shows some of the great camaraderie that we have with our work families. Feels council should scale back on their own regarding directives and discussions instead of resorting to resolutions. Thanked staff for working very hard to get our redevelopment monies secured as this is something that should take first priority.

Councilmember **Vargas** praised Fusion residents for their presence at the last Metro MTA meeting at LAX. Stated that council is in support of Fusion as well as Hollyglen. Thanked all the residents who have visited him during his meet and greet hours. Thanked all the city employees that he has come in contact with these last couple of weeks for helping him with his questions. Thanked code enforcement for their continuing work in cleaning up the Ralph's lot. Thanked Arnie Shadbehr for working with Allied to get the street sweeping and trash pickups coordinated. Thanked Tom Quintana and Rosalinda Martinez for sponsoring the city booth at the South Bay Council of Governments meeting

City Clerk **Huber** announced that the Ramona Neighborhood Association meeting will be held next Thursday at 7pm at Ramona School; voting for officers will take place at this meeting. Had the pleasure of tutoring high school juniors and seniors at the teen center so they could pass their exit exams. Congratulated Jan Vogel for the great programs at the teen center.

City Treasurer **Lubenec** expressed disappointment that major chains like the 99¢ Store and Rite Aid in the city don't seem to get support from corporate and are left to run as they run. Reminded everyone to set their clocks one hour ahead on Saturday night.
