Reported that Hawthorne's involvement in the bicycle master plan is moving forward and areas have been identified where Hawthorne will be connecting with other cities on the route. Requested an urgency moratorium on used car dealerships in order to enact development standards that address compatibility, economic liability, esthetics and minimum lot size. During a recent conference call with Congresswoman Maxine Waters and seven mayors, it was announced that CDBG funds will be down to \$1.5million for 2012 as opposed to \$1.5 million in 2011 and that Home Funds will be down to \$450,000 for 2012 as opposed to \$862,000 for 2011. When the time comes, Council will be taking a hard look into where these monies are invested. Requested a soft copy of a power point presentation on how to plan a community event. Congratulated Jan Vogel on winning the Danny Juarez Ping Pong Tournament held at the Teen Center, which celebrated its 3rd year. Announced that Trinity Lutheran just opened up a new child care center which takes kids as young as six weeks old. Thanked everyone in the city that does a fabulous job to make the Council and the city look good. Wished everyone a Merry Christmas and a Happy New Year.
